There are no windows or other obvious ways to circulate air in my work space, can you help me fix this?



Leave Options

Reason for Leave	Leave Option
YOU have COVID/Told to Self-Quarantine by Doctor	Admin Leave with Pay if exposed at AACPS/Your own leave if not
Experiencing COVID-19 symptoms and seeking a medical diagnosis. or Caring for an individual who is subject to federal, state, or local quarantine or isolation related to COVID-19 or the individual was advised to self- quarantine related to COVID-19	Accrued leave (sick/annual/personal business)
Caring for a child whose school or place of care is closed (or childcare provider is unavailable) for reasons related to COVID-19	Annual leave or Personal business
Contracted COVID-19 and cannot telework	Accrued leave (sick/annual/personal business) or authorized leave without pay
Spouse, child, parent, or permanent household member with a CDC-qualifying underling health condition and cannot telework	No leave available
