What is Robert's Rules?

• First Edition published in 1876 by US Army Major Henry M. Robert

 Intended to be a universal set of rules of parliamentary procedure for organizations of any size

 Keeps debate organized and moves toward a conclusive end




Pros and Cons

- RR's compels democratic organizations to reach decisions – no dithering!
- Assumes every participant understands the rules
- RR is complex and those who understand it are advantaged over others
 - This leads, ironically, to non-democratic outcomes where those without the prerequisite knowledge are excluded from the process

RR Basic Structure

Key Terms:

"The Body": The group of people empowered to vote and debate (in our case, building reps)


"The Chair": The person who facilitates debate (in our case, the TAAAC President)

"The Floor": The literal and metaphorical arena of debate



Do the Loco-MOTION


- Motions are the basic building block of debate
- Typically, a motion is a Proposal that requires the Body to reach a vote and decision
- All votes are decided through simple majority (50%+1)
- Motions come in a variety of types





Common Motions

- Amendment: a proposal to change the current motion on the floor
- Call the Question: a proposal to end debate on the current motion
- Adjourn: ends the meeting





Flow of a Motion

- 1. Member of the Body proposes a **Motion**
- 2. All motions require a "second" someone else literally just yells that out
- 3. Debate then begins on the motion with the Chair calling on individuals to speak either **FOR** or **AGAINST** the motion
- 4. Anyone can propose **Amendments** to the current motions, which also require a Second
- 5. Once debate ends, or there is a successful **Motion to Call the Question**, the Chair calls for a Vote



Debate Process



Motion Example

Main Motion: Jamal Jones – Washington High School - I move that TAAAC order pizza for the next meeting.

Chair: The Chair recognizes the motion. Is there a second?

Another Delegate: I Cheryl Smith--Franklin Elementary School--second the motion.

Chair: So moved. Is there any discussion on the motion?

Another Delegate: I Frank Perez—Tubman Middle School--move to amend the current motion to replace ordering pizza with having a salad bar.

Another delegate: Janice Hall—Douglass Elementary School—I second!

Chair: I will now only recognize those who wish to speak for or against the Proposed Amendment "we order a salad bar"



Key Points

MSEA

- 1) There can only ever be ONE Active Motion at a time
- 2) Amendments always take precedence over the original motion
- 3) Motions to Call the Question require their own separate vote which *temporarily* supersedes the Active Motion
- 4) Successful motions to Call the Question only END DEBATE on the Active Motion, they do not count as the actual vote to accept or reject the Active Motion
